1. Minutes of Meeting Agreed

Minutes of meeting of 29 October agreed subject to amending Item 2 to clarify that the proposal put to Persimmon suggests the 90 day timescale would run from the date of an agreed photographic schedule of condition, not the date of the meeting (23 October). Proposed by DD, seconded by GB.

2. Access to Sandfields

Following the meeting held at the Lichfield District Council Offices on 23rd October, attended by Cllrs Mike Wilcox and Ian Pritchard together with Tim Brickley from Persimmon Homes and Dave Moore, Gill Bellenie, David Dundas and Chris Pattison from LWT, a proposal dated 6 November 2015 has been submitted to Persimmon Homes Ltd for the handover of Sandfields Pumping

Station and the surrounding land currently owned by Persimmon Homes to the Lichfield Waterworks Trust. Tim Brickley is leaving his position with Persimmon Homes before Christmas so pressure is being put on him to reply substantively to the proposal before then. Councillors Wilcox and Pritchard and Michael Fabricant MP have been copied in and notified about the progress so far.

3. Task Force Proposals

LWT are in consultation with South Staffs Water with regard to carrying out basic maintenance work at two of their non operational sites, namely Brindley Bank at Rugeley and Crumpwood Ram Pump House near Uttoxeter. Asbestos clearance awaited from SSWC. A scheme to generate electricity using the water turbines at Crumpwood was still under investigation, with further information made available to CP this week.

Action CP/DM

Investigations into the refurbishment of two information boards to reflect the Lichfield Water Story were ongoing. Awaiting reply from Rotary Club after sponsorship funds requested from them.

Action GB

It was understood that an application for a Heritage Lottery Grant was to be submitted to carry out certain improvements around Stowe Pool. KG had met briefly with Ruth from the Parks Department to offer support and information. A drop in session at The Hub, Beacon Park, is planned for 11am to 3pm Saturday 28 November to see what the community views are. 3 walks around Stow Pool are being planned for May 2016 as a pilot.

4. Chairman's Report

LWT have been successful in applying for a grant towards a gazebo to be used at Fairs, Fetes, etc. A very generous sum of £1000 has been awarded, enough to buy a light but strong gazebo, gazebo sides, and to have personalised lettering on the gazebo. A cheque presentation will take place in the next few weeks. Thank you Bower Charitable Trust.

The proposed interviewing of more former South Staffs Water employees would be held over until after Christmas.

DM has made making presentations to the St Chad's Rotary group and Lichfield City Council. Talks are planned for the Lichfield Women's Group and to U3A in February 2016 and the Round Table 41 Group in December. A talk to a local scout group was also planned.

Visit to Leawood Pumping Station on 1st November with Cllr Ian Pritchard was a success.

RG made a well-received presentation to Lichfield Discovered on 9 November and will present to the local IET branch at Higston Vllage Hall 8th Dec at 2pm. KG to add to Facebook page, CP/DM to attend with donations tin if possible.

Heritage Weekend September 2016 will have the Lunar Society as its theme. A brainstorming session will take place in December which it is hoped an LWT representative can attend.

5. Treasurers Report

CP circulated the current financial report. The current combined bank and cash in hand balance was £1,353.12 (plus a £162 uncashed cheque).

Opening a new bank account for LWT was still ongoing. DM/GB/CP have made a joint visit to the local HSBC branch and the account is expected to be opened within 2 to 3 weeks. The Virgin giving system can then be activated, but not from the present web site. Work required to address this.
